

Privacy Policy

Tristar Dynamics LLC ("Tristar Dynamics," "we," "us," or "our") respects your privacy. This Privacy Policy explains what information is collected when you visit tristardynamics.com (the "Site") and how that information is handled.

Scope. This policy applies to the Site only. Our mobile applications, including TactiFunds and Postalist, are governed by their own privacy policies, available within each application and on their respective App Store listings.

1. Information We Collect

Information you provide. The Site contains no forms, account systems, or comment features. The only personal information we receive through the Site is what you choose to send us — for example, your email address and message contents if you contact us at support@tristardynamics.com.

Information collected automatically. We do not operate analytics, advertising, or tracking technologies on the Site. Our infrastructure provider, Cloudflare, Inc., automatically processes standard technical data — such as IP address, browser type, device information, and request logs — as necessary to serve the Site securely and reliably. This processing is described in Cloudflare's Privacy Policy (cloudflare.com/privacypolicy).

2. How We Use Information

We use information we receive solely to:

- Respond to your inquiries and provide support
- Operate, secure, and maintain the Site
- Comply with legal obligations

We do not use your information for advertising, profiling, or automated decision-making.

3. How We Share Information

We do not sell, rent, or trade personal information. We may disclose information only:

- To service providers that operate our infrastructure (such as Cloudflare), solely as needed to provide their services
- When required by law, regulation, subpoena, or other legal process
- To protect the rights, safety, or property of Tristar Dynamics, our users, or the public
- In connection with a merger, acquisition, or sale of business assets, in which case this policy will continue to apply to previously collected information

4. Cookies and Tracking

We do not set cookies. Cloudflare may set strictly necessary cookies for security and performance purposes (such as bot mitigation). Because we do not track visitors, the Site does not respond differently to "Do Not Track" browser signals — there is no tracking to disable.

5. Data Retention

Email correspondence is retained only as long as reasonably necessary to address your inquiry and maintain business records, after which it may be deleted. Server logs are retained by Cloudflare according to its own retention schedules.

6. Data Security

The Site is served exclusively over HTTPS. We limit the personal information we hold to what you send us, and we restrict access to that information to the operator of the business. No method of transmission or storage is completely secure, and we cannot guarantee absolute security.

7. Your Privacy Rights

Depending on where you live, you may have the right to request access to, correction of, or deletion of personal information we hold about you, and the right to opt out of the sale or sharing of personal information. **We do not sell or share personal information as those terms are defined under applicable privacy laws, including the California Consumer Privacy Act.**

To exercise any privacy right, email support@tristardynamics.com with your request. We will respond within the timeframe required by applicable law and will not discriminate against you for exercising your rights.

8. International Visitors

The Site is operated from the United States. If you access the Site from outside the United States, you understand that any information you send us will be processed in the United States, where data protection laws may differ from those in your jurisdiction.

9. Children's Privacy

The Site is not directed to children under 13, and we do not knowingly collect personal information from children under 13. If you believe a child has provided us personal information, contact us and we will delete it.
